

SEPA ENVIRONMENTAL CHECKLIST

Geotest Services, Inc. performed a geotechnical exploration of the site on 5/09/23 and completed their report on 6/22/23. Their exploration consisted of 4 exploration pits, going 7.5 to 9.9 ft below existing surface at that time. Existing soils consisted of 0.9-1.0ft of topsoil, underlain by gravelly sand to 2.0 ft, and Marysville Sand outwash soil below that. The groundwater table was not encountered and a well log from a nearby property indicates that groundwater is approximately 40 feet below grade.

One acre of the site will be cleared and graded to facilitate development of the short plat. Approximately 1600 cy stripping, 20 cy of cut, and 1660 cy fill, excluding pavement section backfill.

No, site is gently sloped and erosion control measures will be in place during and after construction until site is completely stabilized.
