

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist:

Governmental agencies use this checklist to help determine whether the environmental impacts of your proposal are significant. This information is also helpful to determine if available avoidance, minimization or compensatory mitigation measures will address the probable significant impacts or if an environmental impact statement will be prepared to further analyze the proposal.

2-3% slope on the majority of the site with a small portion of the site containing mounded earth with 20% slope. An excavated hole is located at the south end of the site with near vertical side slopes that will be corrected with a grading permit approval.

Sandy loam observed onsite. Per NRCS Soil classification the side has Puget Silty clay loam onsite.

Erosion is possible if soils are left exposed onsite but proper BMPS will be implemented to reduce and eliminate erosion during and after construction.
