CITY INITIATED PROPOSALS

1. **Amendment Type:** Rezone
Applicant: City of Arlington
File Name: York Park Rezone
File No: PLN#913

Description: The City is rezoning a 0.56-acre lot from Public/Semi-Public zoning to Residential Moderate Capacity. The parcel is currently owned the City of Arlington and the eastern parcel of J. Rudy York Park. The city intends to sell this parcel and the future zoning of the property is required to change to make the parcel marketable for development. Approval by the City Council is required for all rezone applications. If the request is granted, the City's Comprehensive Plan Land Use Map and the City's Official Zoning Map would need to be amended.

2. **Amendment Type:** Map Amendment
Applicant: City of Arlington
File Name: Highland Drive Map Amendment
File No: PLN#914

Description: The City is correcting a map error along Highland Drive. This correction involves 5 parcels and City right-of-way. These parcels were inadvertently rezoned to Residential High Capacity during the 2020 Zoning and Future Land Use Map changes. This map change reverts the zoning back to Residential Low Capacity, which is the adopted zoning for the property. Approval by the Council is required for all map changes. If the request is granted, the City's Comprehensive Plan Land Use Map and the City's Official Zoning Map would need to be amended.

3. **Amendment Type:** Map Amendment

Applicant: City of Arlington

File Name: Lindsay Annexation Map Amendment

File №: PLN#924

Description: The City is moving the Arlington city limits boundary to include the 16 parcels recently adopted as the Lindsay Annexation. The City pre-zoning of these parcels is not proposed to change. The zoning for the property remains as Residential Ultra Low Capacity with the Master Planned Neighborhood Overlay. Approval by the Council is required for all map changes. If the request is granted, the City's Comprehensive Plan Land Use Map and the City's Official Zoning Map would need to be amended.

4. **Amendment Type:** Development Regulations Amendment

File Name: Title 20 Development Regulation Code Amendments

File №: PLN#915

Description: The City has revisions to most chapters of Title 20 Land Use Code. The City changed the zoning map, created new zoning designations, and has added new residential housing types over the past 2 years. The code amendments reflect these changes and provide necessary revisions to chapters of the code that have not been updated for many years. A. INTRODUCTION

The York Park Rezone is a City-initiated project that is an amendment to the City of Arlington Comprehensive Plan, submitted under the 2022 Comprehensive Plan Update Docket cycle.

B. GENERAL INFORMATION

Applicant: City of Arlington
Project Description: 2022 Comprehensive Plan Amendment
Requested Action: Make a recommendation of approval of the 2022 Preliminary Docket to the Arlington City Council

C. DETAILED PROJECT INFORMATION

York Park is owned by the City of Arlington and located on four parcels. The proposed rezone is for the parcel located furthest to the east, listed under tax parcel 00472500000806, and is approximately 0.56 acres in size. The remaining three lots will stay unchanged and be retained with existing park. The property is currently occupied by a single-family residence and garage/shop. The city has left the single-family residence vacant since the property was purchased in May of 2000. Minimal storage within the garage/shop has occurred over the last twenty years.

The proposed rezone would take the property out of the Public/Semi-Public zoning designation and change the property to Residential Moderate Capacity. The Residential Moderate Capacity is the same zoning designation that is located to the east, south, and west of the park property and would simply extend the zoning to an additional lot.

The City is looking to sell the property and the proposed rezone would allow the property to be placed on the real estate market and sold to an individual or company to develop the property into residential housing units that comply with the Residential Moderate Capacity development regulations. Approval by the City Council is required for all rezone applications. If the request is granted, the City's Future Land Use Map and the City's Official Zoning Map would need to be amended.

D. REGULATORY REQUIREMENTS

1. SEPA COMPLIANCE:

The amendment to the comprehensive plan amendment is subject to provisions of the State Environmental Policy Act (SEPA) and Chapter 20.98 of the Arlington Municipal Code (AMC).

2. PUBLIC NOTIFICATION/INVOLVEMENT

- a. Presentations and/or updates on the proposed land use action to the Planning Commission will occur on March 1, 2022, March 15, 2022, April 5, 2022, and April 19, 2022.
- b. Two Public Hearings will be held at Planning Commission online via Zoom or in person located at Arlington City Council Chambers on the following dates, March 15, 2022, and April 19, 2022. The Public Hearing Notice will indicate if the meeting is online or in person.
- c. The City will present information and advertise the Public Hearings regarding the Planning Docket Amendment York Park Rezone, PLN#913, in the Everett Herald, and distributed to all properties within 500' feet of the subject property.
- d. A Notice of Public Hearing for the March 15, 2022 and the April 19, 2022, Planning Commission meeting will be posted at the Arlington Library, City Hall, and City Website. The Notice will also be published in the Everett Herald, posted on site, and distributed to all properties within 500' feet of the subject property.

3. WASHINGTON STATE DEPARTMENT OF COMMERCE NOTIFICATION

The York Park Rezone, along with the additional docket items will be submitted to the Washington State Department of Commerce (DOC), and the DOC will notify the City that if it is in procedural compliance with RCW 36.70A.106.

E. BACKGROUND INFORMATION

Staff has reviewed the draft findings during review of the project and finds that the applicant has met the intent of all applicable requirements and standards. The plan supplements the Comprehensive Plan, through planning goals: PH-1.1, GH-2, PH-2.1, GL-1, PL-1.2, GL-7, PL-7.1, PL-7.2, GL-8, and PL-8.1. The rezone will contribute to a variety of housing types and densities, located near commercial and employment centers.

F. ANALYSIS

Staff recommends that the Planning Commission recommend for approval of the 2022 Preliminary Docket, the rezoning of tax parcel 00472500000806 from Public/Semi-Public to Residential Moderate Capacity by City Council.

G. FINDINGS AND CONCLUSIONS

1. Public meetings will be held on March 1, 2022, March 15, 2022, April 4, 2022, and April 19, 2022.
2. The Comprehensive Plan Amendment and associated staff report will be submitted to the DOC in accordance with RCW 36.70A.106 and the submittal will meet all DOC's procedural requirements.
3. On March 1, 2022, the Planning Commission will review a draft of the City of Arlington 2022 Comprehensive Plan Docket at their workshop meeting.
4. On February 25, 2022, a Notice of Public Hearing for the March 15, 2022, Planning Commission public hearing online via Zoom will be posted at Arlington City Hall, Arlington Public Library, and the City's Website, as well as on site.
5. On April 1, 2022, Notice of Public Hearing for the April 19, 2022, Planning Commission public hearing via Zoom or in person and will be posted at Arlington City Hall, Arlington Public Library, and the City's Website, as well as on site.
6. The application for PLN#913 has been reviewed for consistency with the Arlington Comprehensive Plan and for internal consistency and the 2022 Comprehensive Plan amendments are consistent with, and internally consistent with, the Arlington Comprehensive Plan.
7. PLN#913 has been reviewed in accordance with, and is consistent with, the Snohomish County Countywide Planning Policies.
8. The proposed Comprehensive Plan Amendment was prepared in accordance with the Washington State Enabling Legislation (RCW 35A.63) and the Growth Management Act.
9. Documentation supporting the findings of fact is in file PLN#913, which is adopted by reference into this approval.
10. Adoption of the proposed Comprehensive Plan Amendment, PLN#913, furthers the public health, safety, and general welfare.

H. RECOMMENDATION

Staff recommends that the Arlington Planning Commission make a recommendation to the Arlington City Council to approve the 2022 Preliminary Docket, York Park Rezone, 2022 Comprehensive Plan Amendment, PLN#913.



A. INTRODUCTION

The Highland Drive Map Correction is a City-initiated project that is an amendment to the City of Arlington Comprehensive Plan, submitted under the 2022 Comprehensive Plan Update Docket cycle.

B. GENERAL INFORMATION

Applicants: City of Arlington

Project Description: 2022 Comprehensive Plan Amendment

Requested Action: Make a recommendation of approval of the 2022 Preliminary Docket to the Arlington City Council

Exhibits: Highland Drive Application, Narrative, and Map

C. DETAILED PROJECT INFORMATION

The City of Arlington has four properties that were inadvertently changed from Residential Low Capacity to Residential High Capacity during the 2020 adoption of Ordinance 2020-019. The four parcels effected are parcel numbers 31051100407400, 31051100407500, 31051100407600, and 31051100401600. These parcels are located at 606, 610, 624 E Highland Drive, and one address is unknown. The parcels are located along the frontage of Highland Drive, where Residential High Capacity development is not supported by the Comprehensive Plan or by City Council. These properties were not meant to have the zoning changed and the proposal corrects the Zoning and Future Land Use Maps to align with the current City of Arlington Comprehensive Plan. Approval by the City Council is required for all rezone applications. If the request is granted, the City's Future Land Use Map and the City's Official Zoning Map would need to be amended.

D. REGULATORY REQUIREMENTS

1. SEPA COMPLIANCE:

The amendment to the comprehensive plan amendment is subject to provisions of the State Environmental Policy Act (SEPA) and Chapter 20.98 of the Arlington Municipal Code (AMC).

2. PUBLIC NOTIFICATION/INVOLVEMENT

- a. Presentations and/or updates on the proposed land use action to the Planning Commission will occur on March 1, 2022, March 15, 2022, April 5, 2022, and April 19, 2022.

The Notice will also be published in the Everett Herald, posted on site, and distributed to all properties within 500' feet of the subject property.

3. WASHINGTON STATE DEPARTMENT OF COMMERCE NOTIFICATION

The Highland Drive Map Correction, along with the additional docket items will be submitted to the Washington State Department of Commerce (DOC), and the DOC will notify the City that if it is in procedural compliance with RCW 36.70A.106.

E. BACKGROUND INFORMATION

Staff has reviewed the draft findings during review of the project and finds that the City Council has denied multiple attempts to rezone the properties listed to Residential High Capacity.

City Council denied the rezones of Stewart (PLN#274) in 2017 with Ordinance 2017-007 and Tic Toc, LLC (PLN#523) in 2019 with Ordinance 2019-017

The zoning of the subject properties was inadvertently changed in 2020 with the Zoning Map and Future Land Use Map Update. This map correction changes the properties back to the original zoning that was approved by City Council.

F. ANALYSIS

Staff recommends that the Planning Commission recommend for approval the 2022 Preliminary Docket, Highland Drive Map Correction to the future land use map and zoning map of tax parcels 31051100407400, 31051100407500, 31051100407600, and 31051100401600 from Residential High Capacity to Residential Low Capacity by City Council.

6. The application for PLN#914 has been reviewed for consistency with the Arlington Comprehensive Plan and for internal consistency and the 2022 Comprehensive Plan amendments are consistent with, and internally consistent with, the Arlington Comprehensive Plan.
7. PLN#914 has been reviewed in accordance with, and is consistent with, the Snohomish County Countywide Planning Policies.
8. The proposed Comprehensive Plan Amendment was prepared in accordance with the Washington State Enabling Legislation (RCW 35A.63) and the Growth Management Act.
9. Documentation supporting the findings of fact is in file PLN#914, which is adopted by reference into this approval.
10. Adoption of the proposed Comprehensive Plan Amendment, PLN#914, furthers the public health, safety, and general welfare.



Approval by the City Council is required for all Map Amendment applications. If the request is granted, the City's Future Land Use Map and the City's Official Zoning Map would need to be amended.

The Notice will also be published in the Everett Herald, posted on site, and distributed to all properties within 500' feet of the subject property.

3. WASHINGTON STATE DEPARTMENT OF COMMERCE NOTIFICATION

The Lindsay Annexation Map Amendment, along with the additional docket items will be submitted to the Washington State Department of Commerce (DOC), and the DOC will notify the City that if it is in procedural compliance with RCW 36.70A.106.

E. BACKGROUND INFORMATION


